# Type 2 Diabetes, the Epidemic: Trends in Prevalence and Incidence, 2004-2020

Aims/Hypothesis: Only a few studies reported the incidence of type 2 diabetes (T2D). Understanding recent trends in diabetes is vital for planning future diabetes care. This study updated national trends in the prevalence and incidence of type 2 diabetes (T2D) in the Netherlands from 2004-2020.

Methods: The DIAbetes, MANagement and Treatment (DIAMANT) cohort was used. A cross-sectional design with yearly measurements for the study period was used. The prevalence was calculated by dividing the total number of people with T2D by the total number of all residents. The incidence was calculated by dividing new cases of T2D by the resident population at risk during the calendar year of interest.

Results: Among men, the prevalence of T2D in the Netherlands increased from 2.3% in 2004 to 6.3% in 2020. Women's prevalence increased from 2.3% in 2004 to 5.3% in 2020. During 2005-2009, the incidence rate for both men and women was relatively stable Between 2010 and 2020, the incidence rate fell about 1.5 per 1000 in both men and women.

Conclusion: From 2004–2020, the prevalence of T2D in the Netherlands more than doubled, with a decreasing incidence from 2010 onwards.

#### Research in context

- What is already known about this subject?
  - o Many studies have reported the increasing prevalence of type 2 diabetes (T2D). However, only a few studies reported the incidence.
  - o In a recent systematic review of all these studies, the incidence fell in over a third of the most high-income populations and increased in a minority of populations. Data from the Netherlands were included, but they date back to 1996.
  - o Understanding recent trends in diabetes, the prevalence and incidence are vital for planning future diabetes care.
- What is the key question?
  - o To update national trends in the prevalence and incidence of T2D in the Netherlands for 2004-2020.
- What are the new findings?
  - o During 2004-2020, the prevalence of T2D in the Netherlands more than doubled, with a decreasing incidence from 2010 onwards
- How might this impact on clinical practice in the foreseeable future?
  - o It demonstrates the effectiveness of preventive strategies, public health education and awareness campaigns contributing to this trend.

#### Introduction

Type 2 diabetes (T2D) is a severe public health concern with a high impact on human life and health expenditure. Many studies worldwide have reported the increasing prevalence of T2D.

Only a few studies reported the incidence. The countries that showed stable or decreasing trends from 2005 on were Europe and East Asia. Understanding trends in diabetes, the prevalence and the incidence is vital for planning future diabetes care. This study aimed to update national trends in the prevalence and incidence of T2D in the Netherlands for 2004–2020, in the total population and per sex and age category.

# Research Design and Methods

# Design and Setting

Data for this study was obtained from the DIAbetes, MANagement and Treatment (DIAMANT) cohort. DIAMANT is a large and complete population-based, dynamic, prospective cohort of persons with diabetes derived from anonymized electronic medical records of Dutch general practitioners who consented to have their regular care electronic file extracted in the PHARMO General Practitioner (GP) Database for research purposes. The Dutch PHARMO GP data is a population-based database containing ~3.2 million Dutch inhabitants in 2020 (~20% of the Dutch population).<sup>2,3</sup> The PHARMO GP data are representative of the Dutch population with regard to the demographic characteristics (sex, age and degree of urbanization) and diagnoses in primary care.<sup>3</sup> The DIAMANT cohort contains structured information on people with diabetes using electronic GP information systems, eg examinations, medication, and diagnoses (including symptoms). In addition, the cohort contains basic information on all citizens registered in the practice. Due to the Dutch healthcare system, nearly every citizen is registered with one GP practice, resulting in a complete population-based patient file representative for the Dutch population. Therefore, a cross-sectional design with yearly measurements for the study period was used.

# Definition of type 2 diabetes

T2D was defined as (1) a GP-recorded diagnosis of T2D (ICPC code T90.02) or (2) two or more recorded prescriptions of drugs used in diabetes (ATC code A10B) within six months. The date of T2D diagnosis was defined as the date of the first recorded diagnosis for T2D or the first prescription, whichever occurred first.

# Study population

All people in the patient file who were registered as present in the GP practice (active) on January 1st of each calendar year were included for the prevalence. In addition, all people with T2D in the cohort who had T2D prior to or on January 1st of each calendar year were included in determining the prevalence on January 1st. The observed prevalence was calculated by dividing the sum of people with T2D by the total number of residents in the patient file per calendar year by sex. The observed prevalence was also calculated per calendar year by sex and age category (0-29 years, 30–54 years, 55–74 years and  $\geq$ 75 years).

For the incidence, all people in the patient file who were registered as being present in the GP practice (active) on January 1st of each calendar year and who were registered for at least one year in the patient file were included. All people with diabetes before January 1st of each calendar year were excluded. The observed incidence of T2D was determined among all people in the patient file who had at least one year of data available, defined as the population at risk. At least one year of data availability was required to ensure each person had an equal chance of being marked as an incident person with T2D. The observed incidence was calculated by dividing the sum of people with incident T2D by the total number of person-time at risk in the patient file for both females and males during the calendar year. Person-time at risk in the patient file was defined as the time between January 1st of the year, or start follow-up in the GP practice, whatever came last, and diagnosis date of T2D, December 31st of the year or end of follow-up in the GP practice, whatever came first.

The guidelines outlined in the Declaration of Helsinki were followed. The ethics research committee of the VU Medical Centre approved the DIAMANT study and appreciated that the study used anonymous data and, therefore, was not subjected to ethics review according to the Medical Research Involving Human Subjects Act (WMO).

# Statistical analyses

Descriptive statistics were used for all analyses. In addition, 95% confidence intervals were calculated around all prevalence and incidence estimates. All data were analyzed using SAS programs in SAS Enterprise Guide version 8.2 (SAS Institute Inc., Cary, NC, USA) and conducted in Windows using SAS version 9.4.

#### Results

Over 2004–2020, the number of active people in the patient file (ie still registered as being present) increased from almost 1 million on January 1<sup>st</sup>, 2004, to approximately 3.2 million on January 1<sup>st</sup> 2020. As a result, the number of people with T2D increased from nearly 22.000 on January 1<sup>st</sup> 2004, to almost 190.000 on January 1<sup>st</sup> 2020. In 2004, the mean age of people with T2D was 63 years (SD: 12); 49% were men. In 2020, the mean age was 68 years (SD: 13), and the percentage of men was 53%.




Figure 1 Prevalence of T2D over time by sex.

Figure 1 shows the observed prevalence of T2D between 2004–2020 by sex. In women and men, the observed prevalence increases over time to a percentage of approximately 6.3 among men and 5.3 among women.




Figure 2 Prevalence of T2D over time by age – men (a) and women (b).

Figure 2 shows the prevalence of T2D between 2004–2020 among men (a) and women (b), stratified by age category. The prevalence has increased in the older age groups, equally in women and men.




Figure 3 Incidence of T2D over time by sex.

Figure 3 shows the observed incidence of T2D in the Netherlands between 2005–2020 among women and men. The incidence decreased from 2010 to 2020, with exception of 2015.

During 2005–2009, the incidence rate for both men and women fluctuated between 3.5 and 4 per 1000 persons in men and between 3 and 3.5 per 1000 persons in women. The incidence rate per 1000 persons decreased from 4.5 in men and 3.5 in women in 2010 to 3.0 in men and 2.0 in women in 2020.

#### Discussion

This study shows that the prevalence of T2D increased between 2004 and 2020, and the incidence decreased after 2011, mainly in the older age categories, equal for women and men.

The slowing of the prevalence and the decreased incidence of T2D suggests a slowing of the diabetes epidemic. The study results confirm what has already been seen in Europe, the United States, and East Asia in the last decade. This discordance underlines the importance of reporting prevalence and incidence rates.

Several explanations for the decreased incidence with a stabilizing prevalence can be suggested. First, the ageing of the population combined with improved survival can explain the increased prevalence. A possible explanation for the decreasing incidence rate can be that the proportion of people with overweight and obesity has stabilized since 2014 in the Netherlands. In 2021, the proportion of overweight was reported to have stabilized at 36% with mild overweight and 14% with obesity. Also, the Dutch population eats more fruit and vegetables, less meat and fewer sugar-containing beverages. Furthermore, studies in the United States mentioned the adoption of HbA1c for the diagnosis of diabetes as a possible explanation for the decreasing incidence rate. However, in the Netherlands, this was not adopted in the national diabetes guidelines. Finally, improved screening for diabetes has been suggested as an explanation for the slowing epidemic. In the Netherlands, the guidelines for diagnosing and treating diabetes in primary care changed in 2013. They advised screening with fasting plasma glucose every three years in people aged 45 and older with risk factors

for developing diabetes.<sup>7</sup> In the previous study by our group, we already reported a diminishing proportion of undetected diabetes between 1989 and 2007.<sup>8</sup> Therefore, it could well be that, during our study period, the pool of undetected diabetes (ie the denominator for calculating incidence) is diminishing faster than the number of newly diagnosed persons with diabetes (ie the numerator for calculating incidence) and, therefore, the incidence of diabetes is decreasing.

The strengths of this study are the representativeness of the cohort for the Dutch population, covering 16 recent years. Moreover, we used data from primary care physicians who diagnosed diabetes with fasting plasma glucose throughout the total period. In addition, GPs are financially incentivized to record patients with T2D correctly, so few patients with T2D are not registered. Nonetheless, there are several limitations. First, we do not know the proportion of undetected diabetes. However, this proportion likely decreased in the last decade, as shown in previous population studies. Second, the population included in our study increased over time. However, we are convinced this will not have influenced the accuracy of the results.

To conclude, this study showed an increased prevalence of T2D with a decreased incidence between 2010 and 2020. This result was more explicit at an older age. The results are relevant for clinical practice in the foreseeable future. It demonstrates that preventive strategies, public health education, and awareness campaigns might have decreased incidence.
